**Sub:** Implementation of the Infant Milk Substitutes Feeding Bottles, and Infant Foods (Regulation of Production, Supply and Distribution) Act 1992, and Amendment Act 2003 and Promotion of breastfeeding practices in Delhi general.

Dear Sh. Satyender Jain Ji,

I wish to draw your attention to a central Act , Infant Milk Substitutes Feeding Bottles, and Infant Foods (Regulation of Production, Supply and Distribution) Act 1992, and Amendment Act2003 for protection and promotion of breastfeeding in India which was enacted to ensure proper feeding of infants and young children to save them from malnutrition.

The Government of India and WHO recommend all babies to be breastfed within an hour of birth. According to the recent data from RSOC, in Delhi only 40% women begin breastfeeding within an hour while 83% deliver in institutions. At the same time 76% babies are weighted at birth. There is a gap when it comes to assisting women for breastfeeding.

This is an area that needs your immediate & kind attention.

## Action includes in 3 areas:

<u>Firstly</u> Implementing the IMS Act by curbing promotion of baby foods and bottles like at chemists shops, sponsorships of meetings of doctors by the baby food companies, etc. <u>Secondly</u>, within health facilities mothers need to be assisted by a skilled counsellor; at time of birth and later for breastfeeding. And <u>thirdly</u> advocacy for better maternity protection for all women particularly in unorganized sector, like universalization of Maternity Entitlements as part of the National Food Security Act. Under the NFSA there is a provision for cash benefit if Rs 1000 for six months for mothers.

This years' theme the World Breastfeeding Week is "Breastfeeding and Work: Lets make it Work". It could be an opportune time to kick start activity around breastfeeding support.

The Breastfeeding Promotion Network of India (BPNI) is 24-year-old recognized organization working in this field, and notified under the gazette of India under G.S.R. No. 540 (E), dated the 27<sup>th</sup> June, 1994.
